We started this year with a lot of disturbances caused because of the Corona virus. The virus effected our day to day lives. But this did not let our team down. Even though the situations were bad, our team took safety precautions, came out of house, and reached many people who were lacking food. We distributed rice, groceries, and food to the needy people. We helped for self-sustainability of Sharon Children Home with the concept of Celebrations by WAYCT.

Even though there is no possibility to get out of house, our team used this time for a cause. Instead of wasting time spending on social media, our team worked on building teams, organising online sessions, and share information to help needy. We launched a new project named Swechha, to create awareness on changes that happen in adolescent age. We organised online trainings and sessions to empower student community.

Once the situations started to get back to normal, we initiated offline events. We did school visits, organised blood donation camps, Children's fest, and offline Adolescent Health Education Training workshops. We started working in Sundaraiah Nagar and a school run by non-profit residing there. One of our biggest achievement's this year is launch of Bhavishya. Bhavishya is book by our team which provides information of various career opportunities available for a student after class 10, and data of scholarships available for students at various stages of student life. Mr. Addanki Sridhar Babu IAS, Mr. Vasireddy Vidhya Sagar, and other guests launched the book. We did not get enough time to visit books as the COVID19 second wave raised schools were closed again. We plan to reach more students with these books once everything gets back to normal.

I thank our volunteers, donors, and advisors who were supporting us and helping us reach more needy. Our team expects the same support in future to support more.

Who we are?

We Are with You Charitable Trust is a non-governmental organization working in the fields of education, environment, health, community, and women empowerment activities. We work to help, guide, and empower people to improve the quality of life among citizens.

Projects

We Are with You Charitable Trust categorised the service activities into nine projects. Each project was either designed or adopted to serve the needs of underserved population across different sectors. The nine projects are

- Annapurna
- Abhaya
- Aarogya
- Bhavishya
- Grandhalaya
- Paryavaran
- Scholarships
- Swechha
- Vaaradhi

The following has been the impact created by all these projects.

Aarogya

We have organised a blood donation camp. In the blood donation camp, we have involved other like-minded NGOs with the initiative named CONNECT. The blood donation camp witnessed more than 50 donors. Each unit of blood can serve three people in total the blood donation camp helped more than 150 needy. Along with the blood donation camps we helped two needy who needed medical assistance.



Abhaya

We have started the concept of Celebrations by WAYCT. We celebrated special days such as birthdays, marriage anniversaries, death condolences, and other important days at orphanages and old age homes. The initiative provided orphanages a sustainable way of generating funds. Under the project, we specifically helped Sharon Children Home at Mangalagiri for their sustainability and also for the wellbeing of children. We organised digital classes, and tuitions to support the children in their academics. We organised adolescent health education training to the kids at Sharon Orphanage. Throughout the year, we have reached more than 950 individuals with the project.



Annapurna

COVID19 has affected lives of people who solely depend on daily wages to survive. To support the families of people who lost livelihood because of the virus, we have organised distribution events to the families in need in Andhra Pradesh and Telangana. We have distributed rice, vegetables, and other essentials. We organised meals on wheels concept to provide food to people on streets during the crisis. Our teams organised food drives during the crisis to support the needy. During the year, we have reached more than 3,000 underserved people and supported them with food donation and cloth distribution services.





Bhavishya

COVID19 caused schools to shut down. Major part of the year all the schools and colleges were closed and hence we did not get more opportunities for school visits. But we have utilised the opportunity to serve students using internet as medium. We organised Student Empowerment Training (SET) online in Zoom platform. With the help of advisors Dr. Lakshmi and Dr. Prabhu Ayyagari, we organised five-day workshop series to help youth lead a happy life.

Once the impact of the virus got reduced and everyone started regular life, we have launched one of our biggest achievements, Bhavishya. Bhavishya is the book by We Are with You Charitable Trust and it contains the data of various career opportunities available for students after class 10, the process to reach them, and data of different scholarships available for students at different stages of student life. The book was launched in the presence of Mr. Addanki Sridhar Babu IAS, Mr. Vasireddy Vidhya Sagar, Mr. Jagarlamudi Anjaneyulu, Dr. Eda Samuel Reddy, and other dignitaries. As the second wave of COVID19 raised, we did not get more opportunities to distribute the books at government schools. We are hoping to distribute them once the impact of COVID19 goes down.

We started working at Sundaraiah Colony, Guntur. The area is with people who are economically backward and need educational assistance for their well being and development. We started working with a charity school Prof. MVS Koteswararao Memorial Upper Primary School in the area. We organised children fest – a concept to unleash the hidden talents in students. We also organised tuitions and study sessions to the students in the area within the school to help the students perform well in academics.

Even though major portion of the year was completely spent in lockdown, our team utilised this as an opportunity and organised several online sessions that benefit student community. Once the lockdown restrictions were lifted, with care we organised events at school to empower students. In this year, we have reached more than 900 students with our activities.



Grandhalaya

The project was initiated to build the gap between the book donors and needy. We have helped book needy by connecting them with book donors to get required books. We opened a mini library at Sharon Orphanage. Our team gathered the data of free educational resources and shared it on different media to create awareness about them and help students become effective learners. With the project we reached more than 50 students.



Paryavaran

As most of the people were at home during COVID19 lockdown, people started playing many challenges to spend their free time. To make these challenges benefit everyone including nature, we have initiated Greenery Challenge. In this challenge, people plant a tree and nominate three of their friends to accept the challenge. Participants were divided into batches and one lucky winner among each batch was given with a gift to encourage more participants to plant trees. We have witnessed more than 50 people participating in the Greenery Challenge.



Scholarships

We have shared the info of scholarships on different media. These scholarships assist students financially and reduce the burden on their parents. We gave scholarships directly to few students based on need. In total, with the scholarship info and direct distribution of scholarships we have reached close to 50 students.



Swechha

Project Swechha is one of our new projects launched this year. With the project we provided online Adolescent Health Education Training to create awareness on child sexual abuse, child marriages, physical and emotional changes during adolescent age, menstrual hygiene and myths around menstruation. Once the COVID19 lockdown was lifted, we started offline awareness workshop at Sundaraiaha Nagar Colony. We distributed pads along with the awareness sessions. We provided internship as trainer and organised offline workshops at Tirupati. In total, we have reached more than 600 people with the project.



Vaaradhi

With the project, we are taking care of 21 students. We provide emotional, educational, and financial support to these students. Each student is assigned with a caretaker to understand the student the performance both academically and behaviourally. We distribute stationery, clothes, and required essentials in case of need to these families. We organised quarterly guardian meet, to let the guardians understand the status of the student.
